They also need to contemplate the possibility of getting embroiled in litigation with Tata Sons, which could be able to enforce the security. The SP Group said the question of default does not arise and there is no restriction on its Tata Sons equity. It's been in talks with lenders to refinance \$2 billion borrowed from Ares SSG and US hedge fund Farallon Capital at over 18% in June 2021, with a tenor of 3.5 years. The debt is held by the Misty family through Sterling Investment Corp. Pvt. Ltd (SICPL), which owns a 33.33% stake in Tata Sons. It was used to pay for the remaining stake in Tata Sons, which is held by another unit, Cyrus Investments Pvt Ltd (CIPL).
